

Terms of use

This Agreement defines the terms of use by Users of the materials and services of the site <https://reemukraine.com/> (hereinafter referred to as the Site).

1. General conditions

Such changes take effect upon the expiration of 3 (three) days from the date of posting the new version of the Agreement on the site. 1.4. The Site Administration does not bear any responsibility for the funds transferred by the User, their refund or refund.

2. User Obligations
